

CRAFT BREWERY BOP PROGRAM INTRODUCED IN NJ & PA

BACKGROUND

In response to the burgeoning craft brewery industry, MSO[®] is adding a Craft Brewery BOP Program to its portfolio of specialty products. Designed for the micro- or nano-brewery exposure, this program is tailored for breweries producing 15,000 or less barrels of craft beer annually. A stand-alone Craft Brewery BOP Policy, Declarations Supplement, and Manual Supplement have been designed.

HIGHLIGHTS

Craft Brewery BOP Policy - BU 04 57 (11 15)

- Food Contamination Shutdown Coverage \$50,000 of coverage is provided for loss of income resulting from a shutdown by a health or governmental agency due to food contamination. \$5,000 is provided for cleaning, replacement of goods, advertising fees, and medical care for afflicted customers.
- Lock Replacement Coverage \$5,000 of coverage is provided to repair or replace locks resulting from loss or theft of door keys.
- **Incidental Alcoholic Beverage Coverage** Coverage for on premises tasting of crafts beers is provided subject to certain limitations..
- **Increased Limits** Increased limits from what is available in the typical BOP policy include:
 - Accounts Receivable \$25,000
 - Consequent Loss \$5,000 for Utility Services; \$2,000 for Mechanical Breakdown
 - Employee Dishonesty \$10,000
 - Outdoor Signs and Satellite Dishes \$5,000

Declarations Supplement

The Declarations Supplement is BU 04 58 (11 15) Craft Brewery.

The Declarations Supplement displays basic limits, revised limits and any specific deductibles.

Manual Supplement

The manual supplement for Craft Breweries displays the coverages, limits and options available as well as the rating procedures. Unless specifically addressed in the Craft Brewery BOP Manual Supplement, the rates & rules in the applicable Businessowners Manual apply.
